
***The Warren County Sheriff's Office is committed to serving the citizens of our great county. Our staff works to ensure the safety and security of our citizens.***

## School Resource Section

Our office is responsible for providing security and services to the Kings Local School District and the Warren County Career Center. Currently there are two Deputy Sheriffs assigned to these schools.

For over 9 years Deputy Kirk Nordbloom served the staff and students at the Warren Career Center. On May 27, 2015, Deputy Nordbloom resigned from our office and retired from law enforcement. Deputy Nordbloom was instrumental in fostering and maintaining our great relationship with the Warren Career Center.



Our office identified Deputy Mark Schulte as a replacement for Deputy Nordbloom. He and Deputy Jonathan Downs are assigned as School Resource Deputies with the Sheriff's Office. Deputy Downs is the School Resource Deputy for the Kings Local School District.

In addition to their daily duties at the schools, both offered many various safety presentations to students and staff members.



# Warren County Jail

Our jail administrator and jail staff oversee the 24 hour operation of the Warren County Jail. During 2015, inmate population remained consistently high.



## Training Section

The Training Section remains dedicated to training to the highest level of professionalism and safety for each and every member of the organization.

During 2015 the training staff facilitated many different types of training sessions totaling **6,205** hours of training for members of the agency. Training sessions included county wide active shooter training, specialized training sessions, and various in-house training sessions.

In addition to training members of the organization, the training section was also instrumental in providing active shooter / intruder training (A.L.I.C.E.) to many school administrators, educators, and court staff members.

During 2015 the fourth annual Citizens Sheriff's Academy was held. This nine week Sheriff's Academy provided insight into the daily operation of the Sheriff's Office.

Our training staff also participates in many details outside of their assigned job tasks. These include the county fair, community events, sheriff's office annual police camp, and many other public events.



## Human Resources / Administrative Services

Our human resources office is responsible for payroll, hiring and maintaining personnel files for 194 sheriff's office employees.

2015 was year of many changes for the sheriff's office. Our office experienced several changes in personnel, both in our deputy sheriff and corrections officer staff.

During 2015 our office processed hundreds of applications for openings for deputy sheriff and corrections officer and deputy cadet. These processed included physical agility testing, written tests, interviews and extensive background examinations. Hundreds of hours are spent selecting the right candidate to be a part of our office.

In 2015 we invited over 300 candidates to participate in our selection process for various positions in our office. Of those candidates we hired 8 deputy sheriffs, 9 corrections officers and 1 cadet deputy.




# Warren County Drug Task Force

The Warren County Drug Task Force (WCDF) is a multi-jurisdictional unit that specializes in the investigation of drug related crimes. These crimes can range from drug trafficking to prescription drug diversion.

The WCDF is made up of the following agencies, Warren County Sheriff's Office, Warren County Prosecutor's Office, Springboro Police Department, Lebanon Police Department, Franklin Police Department, Wilmington Police Department, United States Drug Enforcement Administration, Federal Bureau of Investigation, Homeland Security Investigations, Ohio Bureau of Criminal Investigation, Ohio National Guard, and Ohio State Highway Patrol.

During the year 2015, the WCDF investigated 356 cases, conducted 79 search warrants, eradicated 17 methamphetamine labs, and made 187 arrests.





## Investigative Section

The Investigative Section is comprised of plain clothed detectives that are responsible for conducting investigations into many crimes throughout the county. These investigations can range from Homicide to Identity Theft. This section is also responsible for the issuance of Concealed License Permits (CCW).

In 2015 the Investigation Section investigated 637 cases. Of those cases assigned 477 of them were closed. Of the 477 cases closed 119 were closed with arrest. Many of these crimes were property and non-violent crimes. In 2015 there were 45 Breaking and Entering, 58 Burglary and 228 Theft cases assigned to the Investigative Section.

In 2015 there were 2,366 new CCW permits issued. This was a 60% increase from 2014. There were 1,287 CCW renewals and 49 replacement CCW permits issued.
